

FAFICS HISTORY and MANDATE

The Federation of Associations of Former International Civil Servants (FAFICS), founded in 1975, is the global organization uniting local Associations of former staff of the United Nations System.

Its purpose is to represent, defend and protect the interests of UN retirees around the world, particularly on matters of pension, heath insurance and issues related to their lives as retirees.

THE COUNCIL

- THE 55TH COUNCIL SESSION WAS HELD IN VIENNA, AUSTRIA IN JULY 2025
- THE COUNCIL MEETS ANNUALLY AROUND JULY, THE WEEK BEFORE THE PENSION BOARD MEETING, USUALLY IN THE SAME LOCATION
- SINCE THE COVID-19 PANDEMIC, THE COUNCIL HAS DECIDED TO HOLD MEETINGS IN HYBRID MODE (COMBINATON OF IN-PERSON AND VIRTUAL PARTICIPATION)
- EACH MEMBER ASSOCIATION IS USUALLY ENCOURAGED TO SEND UP TO 4 PARTICIPANTS(EITHER IN-PERSON ONLY, VIRTUAL ONLY, OR HYBRID)

THE BUREAU

- CONSISTS OF ELEVEN (11) MEMBERS ELECTED BY THE COUNCIL FOR A DEFINED TERM OF OFFICE, ACCORDING TO THE FAFICS RULES OF PROCEDURE
- THE PRESIDENT, SECRETARY, TREASURER, AND RAPPORTEUR, OFTEN REFERRED TO AS THE SECRETARIAT
- FIVE (5) VICE-PRESIDENTS
- CHAIRS OF THE FOUR (4) FAFICS STANDING COMMITTEES, SOME POSITIONS MAY BE CONCURRENT
- MEETS VIRTUALLY ONCE A MONTH, USUALLY ON THE 3RD THURSDAY OF THE MONTH; AND AT LEAST ONE IN-PERSON MEETING USUALLY PRIOR TO THE COUNCIL SESSION







STANDING COMMITTEES AND AD HOC WORKING GROUPS

(LED BY A BUREAU OFFICER AND USUALLY INVOLVES ABOUT 5-7 MEMBERS FROM MEMBER ASSOCIATIONS). THESE COMMITTEES REPRESENT THE FAFICS PILLARS:

- PENSION ISSUES
- AFTER SERVICE HEALTH INSURANCE AND LONG-TERM CARE (ASHIL)
- COMMUNICATIONS
- MEMBERSHIP

BASED ON NEEDS AND EMERGING ISSUES, SPECIAL COMMITTEES AND/OR WORKING GROUPS ARE ESTABLISHED BY THE COUNCIL OR THE BUREAU ACCORDING TO SPECIFIC TERMS OF REFERENCE.

MEMBERSHIP IN THESE COMMITTEES ARE BASED ON NOMINATIONS, AND USUALLY REVIEWED/CONFIRMED BY THE BUREAU.

BUREAU: EVERY 3RD THURSDAY OF THE MONTH, VIRTUAL; AT LEAST ONCE IN PERSON PRIOR TO THE COUNCIL SESSION

STANDING COMMITTEES: AS AGREED WITH COMMITTEE MEMBERS

PENSION BOARD: FEBRUARY, APRIL, JULY; WITH COMMITTEE

MEETINGS IN BETWEEN

PRACTICAL TIPS

- Schedule informal chats with the FAFICS Secretariat, Vice-Presidents, Committee Chairs, and Rapporteur
- Ask also for briefings from outgoing Officers who may be willing to share their experience, knowledge and lessons learned while in office
- Visit the FAFICS website regularly, especially the sections under latest news, Governance, Bureau meetings/reports, Standing Committees, and Member Associations
